





Solving Multienterprise Business Challenges Creates Network Data


- Rapidly identify and triage disruptions related to serialized product inventory




What is Serialized Product Intelligence (SPI)?

Analytics application to ensure timely delivery of serialized medicines while reducing operational costs

- Monitor internal & external serialization activities to ensure smooth operations and avoid mistakes
- Resolve issues up to 50% faster to reduce the cost of product delays and disruptions

 Free up resources and avoid the cost of hiring additional employees to support business growth



The Relationship Between Verification & Master Data




- Saleable returns verification will require access to product GTINs
- GTINs must be accurate to ensure proper lookups
- Incorrect or missing GTINs will result in wholesaler delays
- Manufacturers may receive wholesaler penalty fees for missing or inaccurate GTIN information


